AND WHEREAS, in the said trust deed dated 16 September, 2015 which was duly registered in the office of Sub Registrar I, Meerut on 16.09.2015 at Book Number 4, Khand 481 on Pages 241 to 262 at Serial Number 437, the settler appointed Sh. Nageen Chand Jain, Smt. Vinita Jain, Sh. Rahul Kesarvani and Sh. Rishabh Mittal as Trustees in addition to themselves.

AND WHEREAS, all the terms and conditions for running the trust in the proper manner in order to fulfil and achieve the objects of the trust were mentioned in the trust deed which will continue to be followed with the present changes;

The trustees had faced several difficulties in carrying out the activities of the trust, and thereafter several amendments were made from time to time in the trust deed and in order to avoid any confusion, it was felt expedient by the then trustees to execute amended trust deed in respect of the same trust .

Sh. Nageen Chand Jain extended his resignation from the post of president by meeting 01/2016 dated 11th January 2016 due to his illness and got expired on 18 Feb 2016 due to cancer.

AND WHEREAS Smt. Kusum Jain were appointed as trustee by meeting code 01/2016 dated 11 January 2016.

AND WHEREAS, thereafter the trust had taken an enormous shape. During this period Mr. Mahipal Singh , Mr. Rahul Kesarvani, Mr. Rishabh Mittal and Mr. Peyush Sharma resigned from their post and trustee for their personal reasons in the meeting, minutes of meeting code 4/2016 dated 25th November 2016.

AND WHEREAS new appointments of trustees were made in the trust as Mr. Shhalvik Jain (permanent trustee), as trustee in meeting code 05/2016 dated 1st December 2016.

Trust does not have any other property.

AND WHEREAS Mr. Mohit Jain and Mrs. Priyanka Jain were appointed in trust as permanent trustees and Mr. Ajay Jain and Miss Arushi Jain are appointed as trustees in the trust by meeting code 01/2017 dated 10th January 2017.

AND WHEREAS Mr. Peyush Sharma resigned from the trust, meeting code 03/2018 dated 19th august 2018 due to his personal reasons.

AND WHEREAS, a meeting of the Board of the Trustees took place on 27th July 2022 meeting code 2/2022, wherein it was decided to amend a few clauses and to add a few more object clauses in addition to which are mentioned in the earlier Trust Deeds, and which are deemed necessary for the better achievement of the desires of Late Shri Nageen Chand Jain, the founder president of the trust.

AND WHEREAS, in the meeting code 2/2022 held on 27th July 2022, it was decided that , as per the desire of the president and the unanimous consent of all the trustees, that the Trust will open and run all the activities including establishment and administration of Educational Institutions and Universities primarily for the benefit of Jains, however, the benefit of all the activities, including the facility of Educational Institutions and Universities, shall be provided to all the citizens of the country and abroad, be incorporated in the Trust Deed.

AND WHEREAS, now, in spite of the more than 50 percent Trustees been Jain, the settler had desired to run the Trust on totally secular mode. However on 27th July 2022 meeting code









2/2022, the settler proposed to change the mode of the Trust so as to work primarily for the Jain community, however, continuing to provide the benefit of the charitable activities of the Trust to all the citizens and the persons of all the communities.

AND WHEREAS, it has been further decided unanimously, that an amended trust deed be drafted, executed and got registered incorporating all the amendments, resolutions which took place in order to run the trust properly, smoothly and effectively.

NOW THIS INDENTURE WITNESSETH AS FOLLOWS :

1. NAME AND ADDRESS OF THE TRUST:

The name of the Trust shall remain "Dada Gurudev Trust ", and its Head Office will be at Shanti Niketan Vidyapeeth, 6th Milestone Mawana Road, Meerut. The PAN number and banks accounts of the Trust shall remain the same.

And whereas the aforesaid trust "Dada Gurudev Trust" shall be absolute owner of the property dedicated to by the founder Mr. Vishal Jain and detailed below :


Rs. 11,000/- (Rs. Eleven Thousand only).

1. GENERAL :

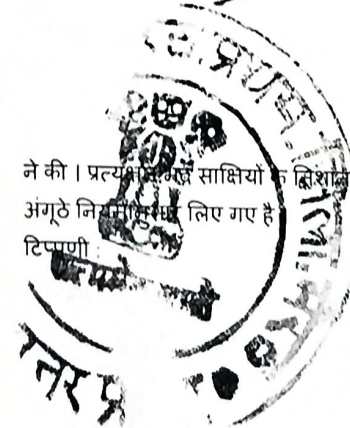

3. DUTIES OF TRUSTEES :




